Information about this children's home

The home is part of an independent children's therapeutic community which is accredited by the Royal College of Psychiatrists. It provides care for up to five children who experience social and emotional difficulties.

The manager has been registered with Ofsted since May 2012.

The children's home is not yet delivering good help and care for children and young people. However, there are no serious or widespread failures that result in their welfare not being safeguarded or promoted.

Inspection judgements

Overall experiences and progress of children and young people: requires improvement to be good

Staff work hard to form positive relationships with the children and to provide them with the appropriate level of affection to help them to know people care about them.

All children attend school and are making academic progress. Two children were recently nominated for an award arranged by their local authority. This achievement has been proudly celebrated.

All children are healthy and are encouraged to make healthy choices. Staff have managed to support one child to attend an appointment with an optician. This has been a significant achievement for the child as they have struggled to attend appointments in the past.

Children are often kept away from each other because of their presenting behaviours. The registered manager explained that this is part of the therapeutic model of care applied in the home. However, records do not demonstrate this in practice.

One child recently moved into the home. This move was well planned, and consideration was given to the matching of children already living in the home. However, essential documents, such as the child's local authority care plan, are not in place. Furthermore, staff spoken to during the inspection were unable to explain the child's care plan.

How well children and young people are helped and protected: requires improvement to be good

Managers have not taken enough action to address a previous shortfall in making sure that allegations raised by children are promptly reported to Ofsted and the local authority designated officer. Consequently, the previous requirement remains unmet. For example, one child's records show that the child made an allegation against a member of staff when he was physically held. The registered manager was not able to demonstrate that the allegation was reported to the local authority designated officer and Ofsted.

On occasions, staff need to physically restrain children to keep them safe. Although staff make a record of these incidents, the details do not align with regulation. For example, staff often complete their own debriefs following a physical intervention.

Staff implement boundaries which children respect. However, on occasions, staff will lock external doors to restrict children's movements to safeguard them. However, this practice is not captured in any agreed care plan.

The effectiveness of leaders and managers: requires improvement to be good

The registered manager has not ensured that systems for day-to-day monitoring and management oversight are in place. This has left shortfalls in record-keeping. The registered manager has recognised this shortfall and has a plan in place to improve this aspect of practice.

Staff feel supported by management, and supervision sessions are regular and reflective. However, some records are not clear as to whether staff have received an annual appraisal.

The home has been impacted by staff shortages. Staff feel that this has been managed well with the support of senior managers and staff from the provider's school coming into the home to cover shifts.

There are gaps in records kept for staff training. For example, records do not show that all staff have attended safeguarding training and completed all their mandatory training.
